

## **KELLER KARES**

We want to be more than a business at Keller Services Heating and Air Conditioning. We want to be involved in our community. As a part of that commitment, we believe in paying it forward and giving back to the community we live in and serve.

While our efforts focus on Tarrant County, we do not limit our giving to a specific timeframe throughout the year. Keller Services offers charitable contributions through new equipment, HVAC repairs and services, event sponsorships, and volunteering our time for special needs, single parents, seniors, and veterans.

Due to the number of requests we receive, we are moving the requirements for solicitation to an application process. Organizations and individuals in the key areas above will be required to apply and provide supporting documents for consideration. Individuals (friends and family members) may nominate others for assistance if they meet the application requirements.

The decisions of Keller Services as to recipients shall be final on all matters concerning charitable contributions. There will be NO required purchases by the organization or individual receiving assistance. Persons who violate any rule, attempt to gain an unfair advantage in the application process, or obtain charitable contributions using fraudulent means will be disqualified and could face legal proceedings.

## **GUIDELINES**

We give as many requests as the budget allows, but it is not feasible to fulfill every request. Therefore, we only consider organizations and individuals that meet the following:

- Organizations must provide direct services to individuals in the Tarrant County area.
- Individuals must live in Tarrant County.
- · Organizations and individuals must clearly state their needs, objectives, and long-range plans.
- All contributions are at the discretion of Keller Services Heating and Air Conditioning.
- Fall within our support area of individuals with special needs, single parents, senior citizens, and veterans.
- To allow for adequate time for review and response, we ask that you allow 30 days from the date received for an answer. Once an application is received, our office will follow up with a call or email.

**Please note:** Donations are eligible to receive support twice a year. Past support does not guarantee future support. You must submit a new application and reapply each time.

## **REQUIREMENTS**

The organization or individual must:

- Be an organization that serves individuals with special needs, single parents, senior citizens, and veterans in Tarrant County.
- Individuals must fall within our support area of individuals with special needs, single parents, senior citizens, and veterans in Tarrant County.
- Organizations must provide proof of 501 (c)3 status.
- Individuals must show proof of homeownership.
- Not have applied for assistance in the immediate 6-months period.
- Apply, and provide all required supporting documents to be considered for a charitable contribution (incomplete applications will not be considered).
- If your application is approved, any promotional or recognition to Keller Services (print or digital) created by your organization must be submitted for approval at least 72 hours before posting.
